In 2009-2013, following a competitive tender procedure, the Energy Department of the Ministry of Energy of Cyprus selected Ioannides Demetriou LLC as its legal advisor for the first and second licensing and bidding rounds, as well as for the drafting and negotiation of the resulting production-sharing contracts for Hydrocarbon Exploration, Extraction and Production off the Southern Coast of the Republic of Cyprus' Exclusive Economic Zone (EEZ). In the above bidding rounds, Ioannides Demetriou LLC, provided legal advice and assistance in negotiations for the preferred bidders for bidding rounds 1 (Noble Energy Inc.) and 2 (Eni/ KOGAS JV and Total) for Hydrocarbon Exploration, Extraction and Production off the Southern Coast within the Republic of Cyprus' EEZ. tential back-to-back long-term gas sup-

ply agreement between the Natural Gas Public Company (DEFA) and EAC for the purposes of the interim supply of gas for power production as well as for the two interim solution LNG tender processes instigated by DEFA. (ETYFA) in which EAC acquired a 30% stake in the ETYFA from DEFA pursuant to a Council of Ministers' decision that paved the way for EAC's equity participation in DEFA;

• The Terminal Users Agreement for the planned Gas Terminal at the Vasilikos site;

• The Terminal Cost Sharing Agreement. Ioannides Demetriou LLC has also advised EAC in the course of negotiations and drafting of SWAP contracts for the purchase of fuel futures for the purpose of power generation. These contracts are the first of their kind used in Cyprus and represent a significant addition to the armoury of EAC in obtaining competitive prices for the fuel oil currently in use for power generation.
